## **1. THE PRIZE COMPETITION**

- 2.5 By submitting your entry, you confirm that you have read and understood these terms and conditions and agree to be bound by them.
- 2.6 Once you have paid your Entry Fee, you will be invited to answer a multiple choice / skill-based question in order to enter the prize competition. Confirmation of your entry will be sent to the email address registered to your account. You will only be entered into the prize competition if you answer the question correctly.

## **3. START AND CLOSING DATE**
